Rotatory Internship at the time of admission/reporting for Round-1 and Round-2 of PG counseling are instructed to submit an Undertaking (Annexure-1) counter-signed by the Head of the Institution (the institution from where such candidates must submit their original Compulsory Rotatory Internship Completion Certificate at the allotted institute on or before allotted institutes specified by the respective counseling authority for 2nd round of PG counselingOtherwise, his/her admission shall stand cancelled. The vacant seatsthusarised shall be added to 3rd round counse ing.
